## 1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, & MOMENT OF SILENCE

Mayor Peggy Bell called the meeting to order at 7:06 p.m. Town Clerk Debra Eastman called the roll with Council Members Roger Coriat, Michael Callahan, Mary Ann Mixon and Mayor Peggy Bell in attendance.

Cub Scout Pack 357 with Leader Jim Bryan presented the colors, led the Pledge of Allegiance and recited the Scout Oath.

Mayor Bell called for a moment of silence for those involved in recent church shootings and all of the victims and families of gun violence.

Council Member Coriat made a motion to pull items 5I, 5J and 5L to be taken up by the Town Council following completion of public comments. Council Member Mixon provided a second. Mayor Bell called for the vote and the motion passed 5-0.

After further discussion, Mayor Bell called for the vote and the motion failed 2-3, with Mayor Bell and Council Member Mixon voting in favor and Council Members Callahan and Coriat and Vice Mayor Loyzelle voting in opposition.
