# 1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, & MOMENT OF SILENCE

Mayor Bell called the meeting to order at 7:35 p.m. Town Clerk Debra Eastman called the roll with Council Members Callahan, Coriat and Mixon present, along with Vice Mayor Loyzelle and Mayor Bell.

# 2. TOWN COUNCIL ANNOUNCEMENTS, BOARD & COMMITTEE REPORTS

Mayor Bell requested permission from the Council to move Item 2C on the agenda and for it to be heard after the Consent Agenda. Council Member Mixon made a motion to move item 2C to follow the consent agenda. The motion received a second from Council Member Coriat. Mayor Bell called for the vote and all were in favor. (5-0)

Due to the large audience attendance, Vice Mayor Loyzelle requested that item 8A and 8B be heard immediately following the time certain item, no matter what items are before the Council at that time. The motion received a second from Council Member Callahan. There was no discussion. Mayor Bell called for the vote and all were in favor. (5-0)

Members of the Youth Council Committee Zoe Storm, Derricha Taylor, Bryan Ruesca and Ms. LaShanda West appeared before the Town Council to thank them for facilitating and funding their recent trip to Tallahassee. Ms. West also thanked the Town Council for their on-going support and invited them to attend the upcoming Youth Council Committee Health Fair being held at Cutler Bay High School on Friday, April 27, 2018. Vice Mayor Loyzelle pointed out that there were funds donated by individuals toward the Youth Council Trip to Tallahassee and extended thanks to those families, as well.

Council Member Michael Callahan reported on the distribution of the report of the Parks and Recreation Committee recommendations for naming of park

facilities. He stated that he would like to meet with Vice Mayor Loyzelle in a Sunshine meeting to discuss a proposed criteria for the naming of Town facilities and bring the proposed criteria to the Town Council for their consideration. After discussion about whether it should be a Town Council Workshop, Council Member Callahan announced that he will work with Vice Mayor Loyzelle in a Sunshine meeting and bring the proposal back to a Town Council Workshop for discussion and from which they could sponsor a resolution.

Vice Mayor Loyzelle announced that the regularly schedule meeting of the Communities for a Lifetime Committee has been changed from May 2 to May 6 since she will be out of town at a conference.

Council Member Mixon announced that the Floodplain Mitigation Committee to which she is the Liaison has received notification from FEMA that the town homeowners now qualify for a 25 percent discount on flood insurance, Council Member Mixon thanked staff for their hard working in making this possible.

Charter Review Commission Chair Terry Long appeared before the Town Council with the fnal report of the Commission. Ms. Long thanked the members of the Commission, the Town Clerk, Town Manager and Town Attorney for their assistance throughout the review process of the Town Charter. She noted that there are only a few recommendations for change and some clean up items on the final report. The Town Council decided to arrange a workshop to further discuss the recommendations of the Charter Revision Commission.

# C. Town Council Efficiency/Decorum

Council Member Mary Ann Mixon expressed her pleasure with the the tone and decorum of the current meeting and read from a written statement regarding previous town council meeting efficiency and council member decorum following a Town Council meeting. There was discussion between Council Member Mixon and Vice Mayor Loyzelle regarding a prevous encounter. Council Member Mixon asked the Town Council to schedule a public hearing on the matter and additionally asked that the behavior cease. There was no action taken.

#### 3. PUBLIC COMMENTS

Bernard Wolff requested that the Town Council consider providing some funds to support the Sons of the American Revolution. Mayor Bell informed Mr. Wolff that there is a process for applying for funds through the Town's trust. Stephan Botbol spoke in opposition to building town homes and adding to traffic.

Council Member Roger Coriat introduced a resolution that had been adopted by the City of South Miami at their March meeting in opposition to extending the Urban Development Boundary (UDB) line further the the west and in opposition to extending SR-836. Council Member Coriat made a motion to urge Miami-Dade County Board of Commissioners to deny the request of the extension of SR-836 and to deny the extension of the UDB further to the west. The motion received a second from Council Member Mixon.

Council Member Mixon also made an amendment that staff prepare a resolution. Vice Mayor Loyzelle provided a second to the amendment. Council Member Coriat stated that he will provide a link for the distribution of the resolution. Mayor Bell called for the vote and all were in favor.

There was discussion regarding the status of the mall's agreement to have public buses drop passengers at the mall door. The Town Council expressed disappointment that the mall has taken so long on this issue and there is still no agreement to allow it.

There was discussion regarding traffic and traffic study methodology, lack of community facilities, density, commercial uses and residential use.

Mayor Bell opened the Public Hearing. Ed Varona, Rizelda Ruiz, Antonia Bucacci, Stephan Botbol, Paul Mathieson, spoke in opposition. Luis Hernandez spoke in favor.

Attorney Juan Mayol rebutted in support of the project.

There was discusion regarding amending the comprehensive plan to permit residential uses to be added and the impact upon alerady high traffic volume.
