# 1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE, & MOMENT OF SILENCE

Mayor Meerbott called the meeting to order at the close of the Local Planning Agency Meeting at 7:10 p.m. Town Clerk Debra Eastman provided roll and all members of the Town Council were still in attendance.

# 2. TOWN COUNCIL ANNOUNCEMENTS, BOARD & COMMITTEE REPORTS

Mayor Meerbott called attention to the monthly reports of the Mayor and Council Members which appear in the agenda. Vice Mayor Loyzelle spoke of the Community for a Lifetime Committee and reported on the election of officers as Chair Jose Rodriguez, Marilyn Rams Vice Chair and new member Irene Royston as Secretary. She reported that the next meeting of the CFAL will be held on April 3 at 6 p.m. Vice Mayor Loyzelle further announced the awarding of a proclamation by Miami Dade County Board of County Commissioners to the Town of Cutler Bay and the Community for a Lifetime for their work on the Age Friendly Action Plan. Mayor Meerbott thanked Vice Mayor Loyzelle for her service and announced that the Florida Legislature will be recognizing Cutler Bay, for the accomplishment of the Age Friendly Plan, during the upcoming Dade Days in Tallahassee in April. Council Member Michael Callahan announced his attendance as the new Liaison

at the guarterly meeting of the Flood Plain Mitigation Committee.

# 3. PUBLIC COMMENTS

Mayor Meerbott opened Public Comments. Stephanie Keime introduced herself as the Chair of the Education Advisory Committee and reported that the Committee discussed item 5C on the consent agenda, a resolution opposing Senate Bill 7030, and that the Committee voted to recommend that the Town Council adopt the resolution. She offered her own personal concerns with the idea of arming teachers.

# 4. REPORTS

# A. TOWN MANAGER'S REPORT

With regard to Resolution 18-83 adopted by the Town Council, Town Manager Rafael Casals requested that the Town Council make a motion to extend an additional 90 days. A motion was made by Vice Mayor Loyzelle and received a second from Council Member Duncan. Mayor Meerbott called for the vote and the motion passed 5-0.

Town Manager Casals called attention to the Town Manager's monthly report included in the meeting agenda.

Town Manager Casals called upon Finance Director Robert Daddario to provide the quarterly financial report for the fourth quarter of 2018. Mr. Daddario reported that the quarter is currently under audit and reported that, subject to FEMA approval for a portion, the year will end with a surplus of \$671,000. He reported that revenues were strong, the Town received some insurance payments, there were budgeted expenditures deferred or cancelled and the Town also received FEMA reimbursements. The Town Council thanked the Town Manager and Finance Director for their diligent efforts.
