# MEMORANDUM

**Re:** Urging Miami-Dade County Fire Rescue Department to Study the Need for a Rescue/Transport Unit at Fire Station 55 - Saga Bay

## REQUEST

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, URGING THE MIAMI-DADE COUNTY FIRE RESCUE DEPARTMENT TO STUDY THE NEED FOR A RESCUE/TRANSPORT UNIT AT FIRE STATION 55 LOCATED IN SAGA BAY; PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE.**

## BACKGROUND AND ANALYSIS

The Miami Dade Fire Department (the “Department”) has provided fire and rescue services to the Town of Cutler Bay (the “Town”) prior to, and since incorporation. The Department is designated as a Class 2/2X Public Protection Classification, as rated by the Insurance Services Office, Inc., and Internationally Accredited through the Commission on Fire Accreditation International. The fire fighters of the Department perform at an extremely high-

level of service and have saved countless of lives within our municipality. The Town is serviced by three (3) stations:

- Station 55 - Saga Bay (21501 SW 87th Ave, Cutler Bay)
- Station 34 - Cutler Ridge (10850 SW 211 St, Cutler Bay)
- Firehouse 50 - Perrine (9798 Hibiscus St, Palmetto Bay)

Station No. 55 - Saga Bay is the busiest station serving our residents and visitors. In 2018, Station 55 - Saga Bay responded to 2,564 incidents accounting for forty-eight (48%) percent of the incidents within the Town. Due to the station’s proximity to multi-family units and town homes located East of Old Cutler Road, the dense population further strains the Department’s ability to respond to incidents. Additionally, the station’s proximity to Black Point Park and Marina, which is the largest public marina in Miami and is part of the Miami-Dade Parks, Recreation, and Open Spaces Department, increases the number of calls to Station 55 [comprised on one (1) fire suppression unit].

Please find below an excerpt from the *Department’s Annual Service Delivery Report* provided by the Fire Chief, during the presentation portion of the Town Council Meetings for the past two (2) consecutive years:

During calendar years 2016 and 2017, MDRFR responded to 10,769 emergency calls received from the Town of Cutler Bay. **Table I** depicts incident type and related response times for incidents MDRFR responded to within the Town during this time period.

\*Expedited response using lights and sirens is only used when responding to Life Threatening and Structure Fire incidents.

The Town of Cutler Bay is primarily served by MDRFR’s Saga Bay Station 55, Perrine Station 50, and Cutler Ridge Station 34 which provided 89% of the responses into the Town during 2017 as depicted in **Table II**.

During calendar year 2018, MDRR responded to 5,416 emergency calls received from the Town of Cutler Bay. **Table I** depicts incident type and related response times for incidents MDRR responded to within the Town during this time period. The data reflected in Tables I and II was produced by the National Fire Operations Reporting System (NFORS). MDRR has recently partnered with NFORS, a project with the goal of improving civilian and firefighter life safety through consistent and quality data.

The Town of Cutler Bay is primarily served by MDRR's Saga Bay Station 55, Cutler Ridge Station 34 and Perrine Station 50 which collectively responded to all of the incidents in the Town during 2018 as depicted in **Table II**.
