REQUEST

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, APPROVING VISUALSCAPE, INC. PURSUANT TO REQUEST FOR PROPOSAL NO. 17-01 FOR THE TOWN'S TREE PLANTING PROGRAM; PROVIDING FOR AUTHORIZATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BACKGROUND AND ANALYSIS

The Town Council on September 21, 2016 via Resolution No. 16-50 authorized staff to issue a Request for Proposal (RFP) No. 17-01: Tree Planting Program. The RFP was advertised in a newspaper of general circulation (*Attachment "A"*) which, complies with the Town's Code Chapter 24, Article II. A "Mandatory" pre-RFP meeting was held on March 7,

2017 at 11:00 a.m., at which time seven (7) potential bidders participated (*Attachment "B"*). The RFP had a due date and time of March 30, 2017 at 4:00 p.m. The Town received three (3) sealed bid packages, from potential contractors which, were publicly opened at Town Hall.

A comprehensive Bid Submittal Review was completed by the Town's Public Works Department (*Attachment "C"*) which resulted in the recommendation of VisualScape Inc. as the "lowest and responsive" bidder.

A copy of first ranked bidder: <u>VisualScape Inc.</u> bid submittal is attached as (*Attachment "D"*).

RECOMMENDATION

Based on Town staff's evaluation of the "lowest and responsive" bidder: <u>VisualScape Inc.</u>, it is recommended that the Town Council approve the attached Resolution.
