### REQUEST

**BACKGROUND**

The Town of Cutler Bay Town Council at the May 16, 2018 reviewed the report of the Charter Review Commission and voted to move forward with calling a special election to add four questions to the November 6, 2018 General Election ballot. The resolution providing for that action has been prepared by the Town Attorney as requested by the Town Council.

**RECOMMENDATION**

In order to provide the proposed amendments to the Town Charter to the voters of the Town of Cutler Bay on Tuesday, November 6, 2018, the required authorizations and ballot questions are contained within the resolution as proposed by the Town Attorney.
